- Camp t-shirt for Wednesday (included in fee must be ordered 3 weeks prior to camp)

General Rules

- Junior camp age limit
 - \circ Age 7 by September 1st following camp up through age 12 OR
 - \circ 6 years with parent who is a counselor staying in the same dorm with them
- Senior camp age limit
 - Age 13 by September 1st following camp through age 18
- No one may leave designated campgrounds without permission of Camp Director
- All campers are expected to attend all activities/services unless excused by head counselor or camp director
- Campers should always be in a group and with a counselor
- Campers may not enter dorms of opposite gender unless area is being used for class sessions
- Campers may not hold hands, hug, kiss, or show physical affection
- No cells phones are permitted for any camper; any camper cell phone must be given to a counselor and only used in their presence to call home
- Campers are not permitted to abuse another camper/counselor's bunk or belongings
- Camp property is not to be abused; campers will be financially responsible for any damaged caused by carelessness or abuse
- All practical jokes must be approved by Camp Director; shaving cream cannot be used for jokes
- Alcohol, drugs, smoking, vaping or any similar activity is not permitted; anyone participating in these activities will be immediately dismissed from camp
- Swimming is gender segregated; t-shirts must be worn over bathing suits; no photos may be taken at pool
- Campers may not have secular music on any media type
- Computers, magazines, worldly books, comic books and other worldly items are prohibited
- Campers are expected to keep themselves and their bunk area clean; there will be daily dorm inspections
- Campers are responsible for their own belongings and money
- Snacks will be available for purchase at the Snack Shack; campers may bring their own snacks and drinks; pop is not permitted in the dorms, meeting rooms, or any carpeted area
- Campers are to obey all counselors, pastors, youth leaders, or any other in authority
- Campers with extreme medical conditions or who are taking prescription medication must be approved by the camp director
- No professional soundtracks or CDs will be permitted for special music; Piano accompaniment CDs are acceptable; Contemporary Christian or Christian rock will not be permitted

Dress Code for Females

- Morning services Culottes/skirts and t-shirts
- Evening services Dresses/skirts with gym shoes, casual shoes, sandals, or flip flops
- Sports Culottes and skirts
- Dresses, skirts, culottes, and tops must be modest not too tight, short, see-through, low, or show cleavage
- Culottes are not shorts they are loose fitting, skirt-like, and below the knee
- Absolutely no pants or shorts permitted
- Slits should not be above the knee
- Clothing must cover knees when you sit
- Tops with worldly/suggestive sayings are not permitted
- Sleeveless tops are ok if neck and arm openings are not revealing
- No crop tops or tank tops
- Shoes must be worn at all times outside dorm
- Gym shoes must be worn during sports flip flops not permitted
- Clothing must be worn over swimwear while going to and from the pool
- T-shirt must be worn over swimwear at the pool
- Sweats and shorts can be worn for nighttime only inside the dorms
- No lingerie will be permitted
- No wild hairstyles or extreme hair colors
- No body piercing jewelry (except earrings)
- Do not send expensive clothing we are not responsible for lost or left items

Dress Code for Males

- Morning services pants and t-shirts
- Evening Pants and collared shirt with gym shoes or sandals
- Sports pants, t-shirt, and gym shoes
- Tops with worldly/suggestive sayings are not permitted
- All shirts must have sleeves no tank tops
- No shorts
- Pants must be pulled up to waist
- No tight pants or shirts; no skinny jeans
- Shoes must be worn at all times outside dorm
- Gym shoes must be worn during sports
- Clothing must be worn over swimwear while going to and from the pool
- T-shirt must be worn over swimwear at the pool
- Hair must be above ears and collar
- No wild hairstyles or extreme hair colors
- No jewelry or body piercings
- Sweats and shorts can be worn for nighttime only inside the dorms
- Do not send expensive clothing we are not responsible for lost or left items

How to be a Great Camp Counselor

Dealing with campers

- Always be prepared to show a camper how to be saved
- Remember that campers see all adults as a counselor, regardless of your position
- Help campers settle in go with your campers to their dorm and make sure they have a bunk and are set up
- Get acquainted with your campers, especially their spiritual condition
- Do not embarrass campers if a rule violation is obvious/serious enough to address with a camper, do it discretely and with a kind spirit
- Use sensitivity when dealing with accidents/sensitive problems
 - There is a washer/dryer on campground take soiled clothes discreetly to Camp Coordinator/Camp Director and they will be taken care of
- Find the tub of extra clothes (usually in girl's dorm) if someone needs appropriate clothes
- Stay with your campers
 - o All campers and counselors are required to attend all services/activities unless ill
 - You are responsible for all campers, but especially those assigned to you
 - \circ $\;$ $\;$ If we are sharing campground, try to keep campers in our area and avoid other groups $\;$

Dealing with Other Counselors

- Do your best to cooperate with all other counselors
- Never side with a camper against another counselor
- If you observe something concerning from another counselor, please report it to the Camp Director
- Work through problems and disagreements in the open; take it to the Camp Director if necessary

Be an Example

- Unmarried counselors should not hold hands/kiss/show public affection
- Married counselors should behave appropriately
- Follow dress code and help enforce them with your campers
- Be understanding of sleeping arrangements/room assignments

Other Key Notes

- Be at orientation with your campers at 9:30pm Sunday night in the Hangar
- Do not let your cell phone become a distraction
- Do not leave the campground at any time unless authorized by the Camp Director we need our counselors on duty
- If driving a vehicle on the campground, use extreme caution
- Campers are not to ride in vehicles unless authorized by the Camp Director
- Medical supplies are in the care of the Camp Nurse
 - All medication is to be kept out of reach of campers
 - \circ $\,$ Do not give any medication to a camper without the nurse's knowledge
 - The nurse is there for serious medical issues; there is a first aid kit with band-aids and other basics in the Hangar
- There is a daily dorm inspection help your campers keep their dorm areas clean
- The campground cleans the restrooms, so please have campers' clothes and trash picked up
- Help keep the pool area clean by taking all of your trash and belongings each day
- Wet clothing can be hung out on the porch railings to dry MAKE SURE your campers have all of their clothes and personal belongings when they leave (especially from the porch). Whatever is left will be thrown away
- The Camp Director's approval is required to leave camp early; camp officially ends on Friday morning after awards
- Visitors are not currently welcomed at this time
- "Lights Out" is at the discretion of the head counselor
 - Please do all you can to ensure your campers get a good night's rest
 - \circ \quad Keep dorm devotions brief so campers can get to bed on time
 - o Do not allow campers to sleep during chapel or other activities
- All concerns/questions should be directed to the head counselor; there will be a male and female head counselor for junior and senior camp. If they are unable to resolve an issue, then feel free to take your problem to the Camp Director.
